STRATEGIC PLANNING

Message from
ShelterBox
Australia Chair,
Paul Roger

“While our strategic direction remains as valid as it has ever been, with the number of people displaced from their homes due to disasters and conflict continuing to rise, in anticipation of the continuance of the pandemic restrictions we set a cautious budget.”

2020-21 saw our second year facing the challenges of COVID 19 restrictions and their impact on all charity organisations in both fundraising and operational activities. Despite these challenges I am pleased to report that ShelterBox globally has embraced innovation and change, adapting to the pandemic restrictions both in fundraising efforts and in the operational deployment of aid. As one of the 14 ShelterBox affiliated countries we have continued to play a vital role in fundraising in support of the ShelterBox international aid deployments.

The Board is responsible for the governance and oversight of our fundraising activities in Australia, ensuring our work aligns with our strategic plan and values. While the CEO manages the day-to-day activities, our directors also give time to assist the CEO where their skill sets can contribute, in areas such as strategic planning, business planning, risk management and financial management. The board has continued to meet virtually each month and participate in sub-committee work as required. Sadly, our annual face-to-face planning meeting had to be cancelled once again due to COVID and our planning conducted through virtual workshops instead.

While our strategic direction remains as valid as it has ever been, with the number of people displaced from their homes due to disasters and conflict continuing to rise, in anticipation of the continuance of the pandemic restrictions we set a cautious

budget. We streamlined our business planning, reduced expenditure, dropped our part-time staff by one, and continued to leverage job keeper support from the federal government. We also revised our approaches to marketing and communication, including the introduction of our inaugural ‘giving day’ in December 2020.

These initiatives together with the continued dedication of our staff and directors saw our income slightly below what we hoped for, but nevertheless encouraging with a slight upward trend towards the end of the year. We have all learned to do things differently, yet remain effective, and I see this as an indication of the underlying strength and resilience of ShelterBox Australia. This without doubt bodes well for the future, as we hopefully return to a semblance of normality in the coming years.

As Rotary International’s partner for disaster relief, this enduring relationship continues to be a foundational strength of our work and I acknowledge the superb support we receive from Rotary Districts, Clubs, and individual members in promoting ShelterBox and raising/donating funds. Not to mention also, the important role played by Rotary clubs and their members close to where disasters strike, in supporting ShelterBox deployments with highly valued local knowledge and support.

As a relatively small organisation, the board plays an important role, and I would like to acknowledge and thank all directors for their passionate, professional, and

constructive support to the organisation and for their positive working relationship with the CEO.

During the year the Board has seen inevitable changes as part of the evolutionary process of a volunteer organisation. Our chairman for five years Rowley Tompsett handed over the reins to me at the start of the year. Rowley made a significant contribution to the development of SBA, and to SB globally. Through his career experience Rowley brought sound knowledge of governance and the ability to build strong, enduring relationships to the Board and the organisation as a whole. I received the organisation in good shape and am pleased to say that with the support of the directors and staff we have continued to build on past foundations, as we continue our journey as a successful disaster relief charity. Directors Nicole Coleman and Tony Monley joined the board early in the year, and Phil Mewett stepped down due to health reasons in December 2020, with Tony stepping into the Financial Director’s role. Company Secretary Barry Antees and Director Emma Black will complete their terms on the Board at the end of the 2020-2021 year and recruitment of replacement directors is well in hand for a smooth handover of roles as we commence the new financial year and maintain a balance of appropriate skills and experience across the commercial sector and Rotary.

As the scale and severity of disasters continue to grow, so does our desire to do more to reach families displaced by disaster and conflict situations.

ShelterBox responds quickly to assist in the immediate response and early recovery phase to provide basic shelter and essential household supplies to families who have lost everything in an instant. While this work is complex and challenging and doesn't often make the headlines, it is transformative to the families we serve.

WHAT MAKES US DIFFERENT

We prepare

We are ready to respond when disaster strikes. We preposition aid in locations around the globe, so it is never far from where it is needed.

We put families first

We work with the most vulnerable families, often women and children. We ask communities and families what they most need to support their own recovery after disaster.

We specialise in providing emergency shelter and the essential tools and materials needed to rebuild homes after a disaster.

THE SHELTERBOX

The ShelterBox contains emergency shelter and the essential basic household supplies that help create the framework for everyday life. Each green box contains a family-sized tent to protect people from the elements and items like solar lights, water filters, blankets, cook-sets, and more. These items help create a home and provide a safe space for families to recover from the physical and emotional trauma of losing everything to a disaster. Depending on the disaster and needs of the community, we customize the ShelterBox to include warm clothing, hygiene items, mosquito nets, ground mats, and even mattresses- whatever it takes to help people recover from disaster.

Shelter is the first step in recovery.

Each Shelter Kit is packed with vital hardware, including various hand tools, ropes, fasteners, and heavy-duty tarps. Often supplemented with locally procured corrugated iron or timber, we provide the essential supplies needed to build a shelter, repair damaged buildings and begin to rebuild a home.

The tools we provide are versatile and are often repurposed to help clear rubble, tend crops, build furniture, cut firewood, make repairs, and even create livelihoods.

We provide training in the field to help families understand how to use their new equipment.

TWO MILLION REASONS TO BE PROUD OF HOW FAR WE HAVE COME

Message from ShelterBox Australia CEO, Mike Greenslade

I think most of us were glad to see the back of 2020. Little did we know that the early part of 2021 would bring much of the same. Border closures and COVID restrictions kept families apart and people locked in their homes. With the vaccine rollout, we are almost certainly through the worst of it, but in many of the countries in which we work, vaccination rates remain worryingly low. We need to remember it is not over until it's over everywhere.

Internationally, ShelterBox met the logistical challenges of remote working with aplomb. By working with partners on the ground, in 2020, ShelterBox provided emergency shelter and supplies to 200,000 people, in 13 countries, through 17 responses. What a great way to mark our 20th anniversary! In April 2020, we passed another important milestone, having helped over two million people worldwide. Although we were unable to deploy any Response Team members, the impact we were able to have on the lives of those affected by disaster and

conflict has been remarkable. In the coming pages, you will read detailed reports on many of these deployments, none of which would have been possible without our generous supporters.

Fundraising remained a challenge, with many face-to-face events unable to take place. The Kokoda Trek and the Cape to Cape Trek had to be cancelled due to border closures, but we did manage to squeeze in the postponed Cradle Mountain Trek in Tasmania, raising over \$30,000. More on this later in the report.

One of the highlights of the year was our inaugural Giving Day. Held to coincide with World Human Rights Day on 10 December, it was so pleasing to see the whole team pull together to make the event such a success. Our supporters dug deep too, donating an amazing \$130,000! We hope this annual event will grow and encourage new supporters, as we promote shelter as a basic human right.

Looking ahead, we hope to follow the success of our second Larapinta Trek with a

shorter Moonlight Trek in Mt Kosciuszko planned for January and a fantastic opportunity in the Southern Alps of New Zealand. Alongside all this activity, Rotary Clubs and Rotarians remain our steadfast supporters, overcoming their own challenges, organising events, and digging deep. Rotary has been in our DNA from the beginning, and it's reassuring to see the partnership stronger than ever after 20 years.

Thanks to our supporters, volunteers, staff, and board, we are turning a corner and look to emerge from recent challenges stronger than ever. The organisation has come a long way in 20 years, and there are more than two million reasons to be proud of how far we have come. Thank you!

AS COVID-19 SPREADS, SHELTER SAVES LIVES

The three essential components to mitigating the global spread of COVID-19 are: healthcare, hygiene, and shelter.

COVID-19 creates a new level of risk for vulnerable families who have lost their homes. Forced to take refuge in crowded camps and makeshift settlements, displaced families who are already vulnerable because of a lack of food, clean water, and underlying health issues are now facing a double crisis. With no ability to socially distance

and little to no access to healthcare facilities, the impact of COVID-19 could be devastating.

Though the global pandemic has made our work more challenging, we are committed to providing vulnerable families with a place to call home through this COVID-19 outbreak.

OUR COMMITMENT TO SHELTERING FAMILIES IS STRONGER THAN EVER.

In 2020, global travel restrictions, closed borders, and disrupted supply chains made it more difficult and costly for us to undertake our vital work. However, our links with local partners worldwide, combined with our globally prepositioned shelter materials, enabled us to continue to provide shelter to families who had lost their homes in the aftermath of conflict, drought, flooding, and volcanic eruption during COVID-19.

MY SHELTERBOX EXPERIENCE

“Having the opportunity to drive from Addis Ababa through the Rift valley to the Somalian border, ride on long boats through canals out to fishing communities on remote Philippine islands, or hike up mountains to jungle villages in Haiti, are experiences that don't come to the average person.”

In 2006-07, I was President of the Goodna Rotary Club and was on the organising committee of the District Conference in Ipswich. The District Governor had recently returned from the DG's conference in Paramatta. During a committee meeting he told us about this little Englishman named Tom Henderson, who was travelling the world speaking to Rotary about setting up fund raising for an organisation called ShelterBox. His aim was to get each District Governor to appoint a District Representative to spread the word among their clubs. In an attempt to avoid some other onerous District duty, I volunteered our club, then duly appointed my International Director as the new District 9630 ShelterBox Ambassador.

Tom was a Keynote speaker at our Conference that year where we raised over \$30,000 for ShelterBox. I hosted a BBQ after the conference and invited Tom and his wife along, and my journey in ShelterBox started over red wine and a steak. A few months later, Tom invited me to train as an ShelterBox Response Team member (SRT) in Cornwall, and suddenly my life changed in so many ways.

I had been in the Air Force for 20 years, lived around Australia, Malaysia, and California, then finally decided to settle the family down in Brisbane. I started a property maintenance business whilst my wife worked full time and had two children in school. How could I fit ShelterBox into an already busy life?

Tom's enthusiasm for ShelterBox was infectious and I became very passionate about the cause, but without my wife's ongoing support it would not have been possible. Every SRT I spoke to had to have a home team to make their ShelterBox journey possible. Weeks away training, 3 am phone calls to see if I could be in Jakarta in 3 days' time, more training, more deployments and then fund-raising commitments when at home meant that ShelterBox became a big part of our lives, and I'll always be grateful for the sacrifices made on the home front.

I was a member of the first structured training course for SRTs and what a great range of people with vast experience and life skills they were. Ex-military, paramedics, retired business people. ShelterBox was bringing in decision makers, people who could act, read the situation, work as a team, thousands of miles from support and get the job done. Many of those people stayed on with ShelterBox and deployed to innumerable disasters around the world and made such an amazing difference in so many lives.

Deployments to New Guinea, Haiti, Indonesia, Ethiopia, and the Philippines allowed me to help so many people whose lives had been devastated by hurricanes, earthquakes, and famine, and to meet and work with some really wonderful, caring people. Getting to know the other SRTs and hearing their life stories was an added bonus of the ShelterBox experience.

Another major part of my ShelterBox journey has been my involvement with the Australian selection process. Luckily, I live next door to a Scout camp which has become the centre for our Australian SRT selection. Providing logistical support, as we bring in ShelterBox staff from Cornwall, New Zealand and around Australia to select prospective AUS and NZ SRTs, has been a great opportunity to catch up with other SRTs and swap our war stories around the campfire. It's also very satisfying to be a part of starting someone else's SB journey.

We've also hosted ShelterBox Ambassadors at the camp, hoping to give a bit of an insight to what we do as an SRT, and maybe help them to impart those experiences when giving presentations. Without these dedicated individuals raising awareness and funds through the Rotary clubs and community events we couldn't do what we do. Hats off to you all!

Having the opportunity to drive from Addis Ababa through the Rift valley to the Somalian border, ride on long boats through canals out to fishing communities on remote Philippine islands, or hike up mountains to jungle villages in Haiti, are experiences that don't come to the average person. It's been a privilege to be part of the ShelterBox family and to experience so many once in a lifetime events. I wouldn't have missed it for the world.



TREK4SHELTER TASMANIA

This is the story of eight everyday people working together wanting to do good in the world. The ShelterBox Tassie Trek was planned for November 2020 but due to Covid19 it was postponed until March 2021. We all know and have experienced how difficult it was to fundraise during this Covid Pandemic. We had to think differently, think outside the square and appeal to people on-line! Promoting ShelterBox in a shopping centre or at a Rotary Club Meeting to create awareness and raise funds was great in 2019 and earlier but no longer possible in 2020 and early 2021. This is why we are so immensely proud that under these circumstances we still managed to raise \$30,469 for our favourite charity ShelterBox.

Simply put, at ShelterBox we know how to “Bring the FUN to FUNDRAISING” the more you get to laugh the easier it gets.

As the ShelterBox Representative on this Tassie Trek I learned of whom I was trekking with just a short time before leaving for Tasmania. Happy to learn one of our Nepal Trekkers from QLD Ian Haylor was also on this trek, but he was the only one I had met before. Everyone on our trek had been on a previous trek or were keen bush walkers. We had two experienced men and six women ranging from late forties to early seventies, a great group of people, five from QLD, two from NSW including myself and one from WA; and five of us were Rotarians.

Our first day was spent driving from Launceston to our accommodation at Cradle Mountain National Park, unpack, and dress for our first easy four-hour trek just to get a feel for the area. Once we were out in the open spaces walking along the board walk, we found ourselves

slowing down by the strong and gusty winds. But to be out in this fresh air and open space was just breathtaking!

Due to the weather forecast of torrential rain we needed to change the planned day two (difficult) to day four (easier) which was such a great decision made by all of us at our first dinner together. Our actual second day was just a longer version of day one. We experienced heavy rain and the wind was so fierce that at times you felt unsteady on your feet, but we did get a good peak at Cradle Mountain in the distance. Day three was a little more adventurous, we were off to Marion’s Peek at 1300 plus metres. There were rumours the final 75 or so metres were extremely difficult and not for the faint hearted. As it turned out I was not the only one concerned and feeling the fear! When we got to the bottom of Marion’s Peak and you could sort of see what was ahead, the decision to continue to the top was unanimous. This was probably the best decision we could have made; our conquest was celebrated by a 360-degree view of the national park and Cradle Mountain was now in clear sight, just awesome! The highlight for us was the number of wombats and their babies we discovered on the last trail back to our bus. The wombats are difficult to photograph as they always have their nose in the grass!

Our accommodation was great! Two-bedroom bungalows with one bathroom and a separate toilet. A great kitchen fully equipped for four people. What we did was turn the bungalow shared by Ian and our tour guide Andrew into the kitchen where all the cooking took place. The Bungalow we all had our meals in I shared with

Kelsey from Inspired Adventures. Everyone would come to our bungalow for their breakfast, one day I got to cook scrambled eggs for everyone, so enjoyable! It was up early in the morning and set up a buffet on the kitchen bench, Kelsey and I had so much fun running our little café! Andrew was not only a brilliant tour guide and there was not anything he did not know about the history of Tasmania dating back thousands of years he was also a great cook! Difficult these days when he also had to cater for us vegetarians and vegans, he was awesome!

Every day was a new adventure, our fourth day we were off to Hanson’s Peak at 1100 plus metres; also a challenging trek. If you have a bucket list, please ensure you add the Cradle Mountain National Park to your list. Don’t do it alone make sure you have an experienced trek leader to look after you and your group. I am also grateful for the partnership ShelterBox has made with Inspired Adventures, we are so confident that our volunteers are in good hands and looked after by these experienced and trained individuals.

Andrew ensured we always stopped in a picturesque spot to have our packed lunch and afternoon coffee with a snack. Time to chat about the day and enjoy each other’s company. We got to take lots of photographs and share them with each other as well. My challenge was always to keep up with the group so that I could hear Andrew’s history and geological stories, they were worth putting in the extra effort.

On our fifth and final trekking day before heading off, we had an early breakfast as we needed to pack and check out of our comfortable accommodations. Our trek was a beautiful walk through a rain forest named Mole Creek. The most amazing trees and four hundred plus years old tree ferns on the way to a stunning waterfall at the end where we stopped for our lunch. We returned the way we came back to our vehicle and back on the road to Launceston, and the Hotel Grand Chancellor. Followed by a well-deserved hot bath and a short rest before gathering back in the lobby for final departing photographs and a meet a greet session with the Rotary Club of Launceston and the ShelterBox Ambassador Bill Dobson.

We then gathered in a different location of the lobby where we had set up a ShelterBox debriefing. Just a 15-minute relaxed update on what was achieved during 2020. Focussing a little on some new product information with the solar lantern and reiterating the need for more volunteers and ambassadors, not necessarily Rotarians.

This was followed by our final dinner at the restaurant of the Grand Chancellor. Lots of thanks, inspiration, and motivation to go around - especially to the lovely Kelsey - for looking after us so well. As Andrew had to get back to Victoria, we acknowledged his contribution in making this such a wonderful adventure. A big thanks goes to both Andrew from Parktrek and Kelsey from Inspired Adventures - they will both be remembered.


In addition to being one of the countries most affected by COVID-19 in South-East Asia, the Philippines has seen a succession of natural disasters in 2020.

TYPHOON VONGFONG: ALEJANDRO'S STORY

Alejandro lives with his wife Jennifer and their 3-year-old daughter Keth in the Philippines' Eastern Samar region. The night **Typhoon Vongfong** hit, Alejandro and his family endured the torrential rain, winds, and chest-level water to escape to safety, taking refuge at Barangay Hall. ***"Our house was completely destroyed. We lost everything inside."***

With ShelterBox aid, the couple repaired their home and rebuilt their lives. With their family safely housed, Alejandro and Jennifer were able to focus on their future, and now run a sari-sari store from the back of their home.

Typhoon Vongfong hit in May 2020 and affected nearly half a million people. ShelterBox quickly responded distributing tarps, rope, and other household items to help 998 families rebuild their homes giving them a safe space to protect themselves from COVID-19.



In April 2020, ShelterBox supplied shelter materials to the Eversley Sanitarium, a public hospital in Cebu, to create extra space to treat patients affected by COVID-19.

RESPONDING DURING COVID-19

In January 2020, the **Taal Volcano** erupted, forcing thousands of families to flee their homes into crowded evacuation centres, increasing the potential spread of COVID-19. We supported 1,937 families with shelter materials and household items to increase space for families and reduce the spread of COVID-19.

In November 2020, **Super Typhoon Goni**, the most powerful storm to hit the Philippines since **Super Typhoon Haiyan in 2013**, ripped through the region south of Manila, destroying 30,000 homes. Two weeks later, **Typhoon Vamco** brought more devastation. We supported 5,176 families in the worst-hit regions with shelter materials.

Since 2004, ShelterBox has responded 31 times in the Philippines: 22 typhoons, 2 floods, 2 conflicts, 3 earthquakes, 2 pandemic responses. Rotary has assisted us on every single deployment since 2004.

95%

In April 2020, Vanuatu was hit by Category 5 Cyclone Harold. The storm destroyed thousands of homes, damaged food crops and infrastructure, and caused widespread power outages.

REBUILDING HOME: SHELLEY'S STORY

Category 5 Cyclone Harold made landfall in April, devastating the island of Vanuatu. Shelley, her children, and their neighbours sheltered together in her home as the storm raged—its powerful winds eventually tearing the roof from her home. The next day, they emerged to find nothing but debris scattered where their homes once stood.


Shelley's was one of 4,365 families who received a Shelter Kit with the essential tools and equipment needed to make home repairs and build a basic shelter. With ShelterBox's support, Shelley and her neighbours rebuilt their homes, community, and gardens.

ShelterBox was the only humanitarian aid organisation from outside the South Pacific able to respond during the global pandemic.

ShelterBox adapted to COVID-19 travel restrictions by conducting remote assessments through local partners and Rotary contacts. We delivered shelter and supplies to Vanuatu by sea freight from our prepositioned warehouse in Dubai.

Thousand of families fleeing violence and economic instability in Nigeria and Cameroon have escaped to Far North Cameroon to access protection and humanitarian aid.

SHELTER FOR MINAWAO CAMP

After Boko Haram attacked her village and destroyed her home, 30-year-old Fanne fled with her children to Minawao Refugee Camp in Cameroon. Initially designed to meet the needs of 30,000 people, Minawao Refugee Camp has swollen to 67,000 people in residence, with new arrivals each day.

Life has improved significantly for Fanne and her family since receiving ShelterBox aid in June 2020. They've moved out of the crowded collective center into their new home where they are safe and socially distanced.

To date, ShelterBox has provided shelter and essential aid to nearly 8,000 families in Cameroon.



82% of aid recipients in Cameroon said they were also using the tools they were given for fieldwork.

A SAFE PLACE TO CALL HOME FOR KALTOUMI

When violent extremist group Boko Haram attacked Kaltoumi's village, they killed her husband and kidnapped her nine-year-old son. Widowed and with ten children in her care, she fled her home in search of safety. They traveled for more than three days before arriving at Zamalva in Cameroon, where living conditions were crowded and put her family at risk of contracting COVID-19.

ShelterBox equipped Kaltoumi with two Shelter Kits, solar lamps, kitchen sets, ground mats, blankets, and water filters. Now, she has a private home to keep her family safe from COVID-19. ***"The shelter I received allows me to keep my children at home and avoid those crowded places."***

Kaltoumi is excited to start her own business, selling food she grows to pay for her children to go to school.

As the sole provider of tents to new arrivals in Minawao Refugee Camp, ShelterBox will continue to do everything we can to provide those in need of a new home with life-saving emergency shelter and basic supplies.

COVID-19 PREVENTION: BULUTNA'S STORY

Ethiopia is the the fastest growing displacement crisis in the world.

Ongoing conflict, drought, flooding, and a locust invasion have displaced more than 1.8 million people.

Bulutna and her family have been living in temporary shelter since armed militants attacked their village and they were forced to flee their home. She says she is planning to gradually return her family's life back to normal, but she is concerned about the recent COVID-19 pandemic.

“I heard about a new virus spreading everywhere, but I didn't know how it spread or how to prevent it. After the lessons we learned from the health official, my family and are now doing everything we can to try to prevent it.”

In 2020, ShelterBox delivered critical shelter aid and household items to families like Bulutna's displaced in the West Guji and Gedeo regions of Ethiopia. We continue to respond with additional aid and shelter as civil unrest builds in the Tigray region.

When the village where Hinda and her five children lived and raised livestock no longer had enough water for her family or herd to survive, Hinda was forced to leave everything behind. She and her family made the difficult journey by foot to a camp for internally displaced people.

At the camp, Hinda and her family built a hut made of old clothes and plastic materials. They had little clean water to drink.

Hinda's was one of 1,800 families who received ShelterBox tarps and rope to build more secure shelter. They also received other household items including a kitchen set, blankets, ground mats, mosquito nets and water carriers.

“Now I am very happy. These tarps will cover the roof of our house.”

The Syrian crisis is the longest response in ShelterBox history. The violent conflict has displaced an estimated 12 million people, and while news of the conflict rarely makes headlines, it rages on with no end in sight.

THE THREAT OF COVID-19

In a country already at war, where millions are displaced and living in emergency shelters, with little to no access to sanitation, COVID-19 poses a deadly threat. Mitigations such as widespread lockdowns, social distancing, and enhanced hygiene measures are almost impossible in a fractured country.

As the fighting continues, millions of displaced Syrians have escaped to crowded camps with little resources. Living in emergency and makeshift shelters, year after year, they face scorching hot summers and brutally cold winters with frequent flooding. This is why we are committed to continuing our vital work.

AID HIGHLIGHT SOAP & HANDWASHING BASIN

99.5% of recipients in Syria said the soap and wash basins helped them adhere to COVID-19 hygiene practices.

FLEEING CONFLICT: UMM'S STORY

Umm and her family lost their home when a plane bombed their village in Syria. ***“Two rockets fell next to us. We fled from our house and took refuge in a cave.”*** They brought only the items they could carry. ***“We left without anything because I thought we would be back.”***

Umm and her family would not return home. They now live in a crowded camp in northern Syria, facing the threat of COVID-19. ***“Life is hard here. The children are always in the tent to prevent them from getting sick.”***

After their arrival, they received a shelter kit with tarps, tools, and other household materials. Now that Umm’s family has a home with blankets and clothing to keep warm, Umm can focus on the future.

Umm and her family are just one of the millions of families who have lost their homes due to the violent conflict in Syria that has lasted more than ten years.

In Syria, 91% of people surveyed said the information provided by ShelterBox and other NGOs increased their understanding of COVID-19. To date, ShelterBox has served 400,000 people caught in the Syrian conflict with shelter, aid and household supplies.

For 22-year-old Pooja, sharing her home with all 10 members of her family, from her 4-year-old daughter to her 60-year-old father-in-law, means everything. *"The fact that we all live together is the thing I love most about my home."*

Their house, made from mud, bamboo fencing and thin metal sheeting for the roof, was severely damaged by devastating winds and flooding and only the things that Pooja had wrapped in plastic survived. ShelterBox was quick to respond, supplying families like Pooja's with tarps, tools and essential aid, enabling them to rebuild their home stronger than before. Without the ShelterBox aid items, this would have been nearly impossible as COVID-19 and lockdown made buying items difficult. Now Pooja and her family can settle back into everyday life, spending time together.



NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

BASIS OF PREPARATION

Shelterbox Australia applies Australian Accounting Standards – Reduced Disclosure Requirements as set out in *AASB 1053: Application of Tiers of Australian Accounting Standards*.

The financial statements are general purpose financial statements that have been prepared in accordance with Australian Accounting Standards – Reduced Disclosure Requirements of the Australian Accounting Standards Board (AASB) and the *Corporations Act 2001*. The company is a not-for-profit entity for financial reporting purposes under Australian Accounting Standards.

Australian Accounting Standards set out accounting policies that the AASB has concluded would result in financial statements containing relevant and reliable information about transactions, events and conditions. Material accounting policies adopted in the preparation of these financial statements are presented below and have been consistently applied unless stated otherwise.

The financial statements, except for the cash flow information, have been prepared on an accrual basis and are based on historical costs, modified, where applicable, by the measurement at fair value of selected non-current assets, financial assets and financial liabilities. The amounts presented in the financial statements have been rounded to the nearest dollar.

ACCOUNTING POLICIES

a) Revenue Recognition

Grant Revenues

Grant revenue, donations and bequests are recognised as revenue when received.

Interest Revenue

Interest Revenue is recognised as it accrues using effective interest rate method, which for floating rate financial assets is the rate inherent in the instrument.

All revenue is stated net of the amount of goods and services tax (GST).

b) Property, Plant & Equipment

Each class of property, plant and equipment is carried at cost or fair value, less, where applicable, accumulated depreciation and any impairment losses.

Plant and Equipment

Plant and equipment are measured on the cost basis less depreciation and any impairment losses.

The carrying amount of plant and equipment is reviewed annually by directors to ensure it is not in excess of the recoverable amount from these assets. The recoverable amount is assessed on the basis of the expected net cash flows that will be received from the assets employment and subsequent disposal. The expected net cash flows have been discounted to their present values in determining recoverable amounts.

Plant and equipment that have been contributed at no cost, or for nominal cost are valued and recognised at the fair value of the asset at the date it is acquired.

c) Depreciation and Impairment

Depreciation

The depreciable amount of all fixed assets including buildings and capitalised lease assets, but excluding freehold land, is depreciated on a straight-line basis over the asset's useful life to the entity commencing from the time the asset is held ready for use. Leasehold improvements are depreciated over the shorter of either the unexpired period of the lease or the estimated useful lives of the improvements.

The depreciation rates used for each class of depreciable assets are:

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at the end of each reporting period.

An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount.

Gains and losses on disposals are determined by comparing proceeds with the carrying amount. These gains or losses are recognised immediately in profit or loss. When revalued assets are sold, amounts included in the revaluation surplus relating to that asset are transferred to retained earnings.

Impairment of Assets

At the end of each of each reporting period, the entity reviews the carrying values of its tangible and intangible assets to determine whether there is any indication that those assets have been impaired. If such an indication exists, the recoverable amount of the asset, being the higher of the asset's fair value less costs to sell value in use, is compared to the asset's carrying value. Any excess of the asset's carrying value over its recoverable amount is recognised immediately in profit or loss.

Where the future economic benefits of the assets are not primarily dependent upon the asset's ability to generate net cash inflows and when the entity would, if deprived of the asset replace its remaining future economic benefits, value in use is determined as the depreciated replacement cost of an asset.

Where it is not possible to estimate the recoverable amount of a class of asset, the entity estimated the recoverable amount of the cash-generating unit to which the asset belongs.

Where an impairment loss on a revalued asset is identified, this is debited against the revaluation surplus in respect of the same class of asset to the extent that the impairment loss does not exceed the amount in the revaluation surplus for that same class of asset.

d) Employee Entitlements

Provision is made for the company's liability for employee benefits arising from services rendered by employees to the end of the reporting period. Employee benefits that are expected to be settled within one year have been measured at the amounts expected to be paid when the liability is settled. Employee benefits payable later than one year have been measured at the present value of the estimated future cash outflows to be made for those benefits. In determining the liability, consideration is given to employee wage increases and the probability that the employee may not satisfy vesting requirements. Those cash outflows are discounted using market yields on national government bonds with terms to maturity that match the expected timing of cash flows attributed to employee benefits.

Contributions are made by the entity to an employee superannuation fund and are charged as expenses when incurred.

e) Cash and Cash equivalents

Cash and cash equivalents include cash on hand, deposits held at-call with banks, other short term highly liquid investments with original maturities of three months or less and bank overdrafts. Bank overdrafts are shown within short-term borrowing in current liabilities on the statement of financial position.

f) Accounts Receivable and Other Debtors

Accounts receivable and other debtors include amounts due from donors and any outstanding grants receipts. Receivables expected to be collected within 12 months of the end of the reporting period are classified as current assets. All other receivables are classified as non-current assets.

g) Goods and Services Tax

Revenues, expenses and assets are recognised net of the amount of goods and services tax (GST), except where the amount of GST incurred is not recoverable from the Australian Taxation Office. In these circumstances, the GST is recognised as part of the cost of acquisition of the asset or as part of an item of the expense.

Receivables and payables in the Statement of Financial Position are shown inclusive of GST.

The net amount of GST recoverable from, or payable to, the Australian Taxation Office is included other receivables or payables in the statement of financial position.

Cash flows are included in the statement of cash flows on a gross basis. The GST components of cash flows arising from investing or financing activities which are recoverable from, or payable to, the Australian Taxation Office are presented as operating cash flows included in receipts from customers or payments to suppliers.

h) Income Tax

No provision for income tax has been raised as the entity is exempt from income tax under Div. 50 of the Income Tax Assessment Act 1997.

i) Provisions

Provisions are recognised when the entity has a legal or constructive obligation, as a result of past events, for which it is probably that an outflow of economic benefits will result and that outflow can be reliably measured. Provisions recognised represent the best estimate of the amounts required to settle the obligation at the end of the reporting period.
